Dog Training Services Waiver & Release Agreement

This Dog Training Services Waiver and Release Agreement (the “Agreement”) is entered into between the undersigned (the “Client”) and *Golden Boy Dog Training, LLP* (the “Trainer”), located at *2122 184th St NE, Arlington, WA 98223*, for the purpose of engaging in dog training services (the “Services”).

1. Vaccination Requirements and Medical Records Verification

The Client agrees to ensure that their dog is up-to-date on the following vaccinations:

- Rabies
- DHPP
- Lepto
- Bordetella (Kennel Cough)
- Other vaccines or health records as deemed necessary by the Trainer

The Client must provide proof of vaccination prior to the start of training sessions. The Trainer reserves the right to refuse service if the dog does not meet these vaccination requirements.

Furthermore, by signing this Agreement, the Client gives the Trainer permission to verify their dog’s vaccination and medical records with the dog’s veterinarian. The Client agrees to provide the Trainer with the necessary contact information for the veterinarian and authorizes the Trainer to request and receive the relevant medical records, including vaccination history, to ensure the dog is fit for training.

2. Acknowledgment of Risk

The Client understands and acknowledges that participation in dog training involves certain inherent risks, including but not limited to potential injury to the dog, other animals, or people. These risks may arise from the dog’s behavior, the training techniques used, or the environment in which the training occurs. The Client agrees to assume all risks associated with participation in the Services, whether known or unknown, and accepts full responsibility for any injuries or damages that may result.

In particular, the Client acknowledges that in Washington State, as in other states, certain dog breeds and behaviors may be subject to restrictions or liability concerns, and agrees to take responsibility for ensuring the dog complies with all local ordinances.



3. Health and Behavior Disclosure

The Client warrants that the dog(s) participating in the training are in good health and have no known medical conditions that would preclude them from participating in the training. The Client agrees to disclose any history of aggression, special behavioral needs, or other factors that may affect the dog's participation in the training sessions. The Trainer reserves the right to refuse service to any dog deemed unsafe or unsuitable for the Services based on the information provided.

4. Veterinary Care

In the event of an emergency or injury to the dog during training, the Client authorizes the Trainer to seek immediate veterinary care, and agrees to be responsible for all associated costs. The Client understands that the Trainer will make a good faith effort to contact the Client prior to obtaining care, but may proceed with seeking veterinary assistance if the Client cannot be reached.

5. Release of Liability

The Client agrees to release, waive, and discharge the Trainer, its employees, agents, and affiliates from any and all claims, liabilities, or causes of action arising out of or related to injury, loss, damage, or illness that may occur to the Client, the dog(s), or any third party during or as a result of the Services, whether caused by the negligence of the Trainer or otherwise. This release extends to personal injury, property damage, or loss, to the fullest extent permitted by Washington State law.

The Client acknowledges that Washington State law holds dog owners responsible for injuries or damages caused by their dogs, including injuries to other people or animals. The Client agrees to indemnify and hold harmless the Trainer from any such claims resulting from their dog's behavior.

6. Indemnification

The Client agrees to indemnify, defend, and hold harmless the Trainer, its employees, agents, and affiliates from any and all claims, damages, costs, or expenses (including reasonable attorneys' fees) arising from the Client's actions or omissions, including any injury or damage caused by the dog during the training process. This includes but is not limited to any claims from third parties.

7. Training Environment and Facilities

The Client acknowledges that the training environment, whether in-person or virtual, may present risks, and agrees to follow all rules and instructions provided by the Trainer to ensure safety. The Client agrees to adhere to the Trainer's guidelines regarding dog behavior, safety, and control during the training sessions. Any failure to comply with these guidelines may result in the termination of the Services at the Trainer's discretion.



8. Photo and Video Release

The Client grants the Trainer permission to take photographs and/or videos of the dog during training sessions for promotional or educational purposes, including but not limited to use on the Trainer's website, social media, and marketing materials. The Client understands that no compensation will be provided for such use. If the Client does not wish for photographs or videos of the dog to be used, they may request that the Trainer refrain from doing so in writing.

9. Termination of Services

The Trainer reserves the right to terminate the training services at any time if the Client's dog is deemed dangerous, if the Client is non-compliant with the Trainer's instructions, or if the Client's conduct is disruptive or unsafe. No refunds will be issued for any services terminated due to these reasons.

10. Payment and Fees

The Client agrees to pay all fees associated with the Services as outlined in the Trainer's pricing schedule. Payments are due at the time of service unless otherwise agreed. The Trainer reserves the right to charge additional fees for any late payments, missed sessions, or cancellation fees.

11. Governing Law and Dispute Resolution

This Agreement shall be governed by the laws of the State of Washington, without regard to its conflict of law principles. Any disputes arising from this Agreement shall be resolved through mediation or arbitration in Snohomish County in Washington State. The Client and Trainer agree to seek resolution of disputes through informal negotiation and, if necessary, formal mediation, before pursuing legal action in a court of law.

12. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, whether written or verbal, related to the subject matter hereof. No modifications or amendments to this Agreement shall be valid unless made in writing and signed by both parties.
